# **MASTERING PATHOLOGY SUMMIT TERMS AND CONDITIONS**

Bio Concepts Pty Ltd (Us, We) is the organiser of the Mastering Pathology Summit (the Event). The Mastering Pathology Summit is being delivered as a hybrid Event. The face-to-face Event will be held at The Westin Brisbane from Friday 25 to Saturday 26 October 2024. Virtual delegates will be able to view all Summit plenary sessions via the virtual Event platform. By purchasing a ticket to the Event, you agree to be bound by the terms and conditions contained in this document.

# FILMING / RECORDING POLICY

Delegates are not permitted to film or record any speaker presentation at the Event unless written approval is obtained from us in advance. Bio Concepts will be filming the speaker presentations for the Livestream and will provide ticket holders with a copy of the recording post-event.

By participating in this Event, you acknowledge and grant Bio Concepts the right to record, film, live stream, photography, or capture you in any media now available or hereafter developed and to distribute, broadcast, use, or otherwise disseminate, in perpetuity, such media without any approval from you.

## **CONFERENCE CANCELLATION**

- We reserve the right to cancel or postpone the Event for any reason.
- In the Event of the cancellation in advance of the Event, we will provide a full refund.
- In the Event of a cancellation or postponement due to Government order, Bio Concepts reserves the right to reschedule the Event and offer an exchange to the rescheduled Event.
- In the Event of a rescheduled Event, ticket holders will be contacted directly via email and presented with options to receive an exchange to the rescheduled Event, or to request a refund. You will have 28 days to respond.
- If you fail to respond to our email within 28 days of the email being sent, you will be deemed to have accepted the exchange of tickets and your tickets will be valid for the rescheduled Event.
- If you purchase the tickets on the behalf of a group of people, you will be responsible for communicating such changes with other members of your group.
- Refunds will be processed within 14 days of communication from Bio Concepts confirming refund approval.



## **REFUND POLICY**

Bio Concepts understands that circumstances can change. At any point prior to the Mastering Pathology Summit you are welcome to contact us in writing to nominate a substitute delegate at no extra charge. Should ticket substitutes be required, they will conclude up to 10 days prior to the commencement of the Mastering Pathology Summit on Friday 25<sup>th</sup> October, 2024 unless otherwise specified by the Event organiser. There will be a maximum of one (1) reissue permitted per ticket unless otherwise specified.

If you cannot nominate a substitute delegate for your in-person ticket (Ultimate or Green ticket), Bio Concepts will refund you the difference between a face to face and virtual ticket – up to 45 days prior to the Event.

For example, if you purchased a super early bird Ultimate ticket at \$480 and you advise us at least 45 days prior to the Event that you are unable to attend, Bio Concepts would provide a refund of \$225, and you would still be able to attend the Event virtually and receive the recording post-event.

Delegates must forward their refund request in writing to <u>info@bioconcepts.com.au</u>. Refunds will be processed within 14 days of communication from Bio Concepts confirming refund approval. Refunds will be directed to the credit card used to make the original registration booking.

No refund will be issued for Virtual tickets purchased.

If you are unable to attend the Event and no substitute delegate is nominated, or the substitute delegate fails to attend the Event, we will not provide any refund of the ticket price.

We reserve the right to offer refunds to people in extreme circumstances.

## IN THE EVENT OF A GOVERNMENT MANDATED LOCKDOWN (IN-PERSON TICKET HOLDERS):

In the instance that a government mandated lockdown or travel restrictions prevents you travelling to Brisbane for the face-to-face Event, Bio Concepts will refund you the difference between a face to face and virtual ticket. For example, if you purchased a super early bird Ultimate ticket at \$480 but were not able to travel due to restrictions, Bio Concepts would provide a refund of \$225, and you would still be able to attend the Event virtually.

We will use all reasonable endeavours when we receive requests to upgrade tickets. You acknowledge and accept that such upgrade is subject to availability and may not be possible. If the ticket upgrade is agreed to by us, you agree to pay any difference in the original ticket price and the upgraded ticket type prior to us issuing the ticket upgrade.

If Bio Concepts are unable to reschedule the face-to-face Event, Bio Concepts will issue you a non-transferable credit note for the amount of the Fee (less the Fee for the Virtual Event, provided the Virtual Event is able to proceed), which may be redeemed against any appropriate future Bio Concepts Education Event for a period of 24 months from the date of issue.
